Ottawa SAH Rule

The Ottawa Subarachnoid Hemorrhage Rule is for alert patients > 15 years old with new severe non-traumatic headache reaching maximum intensity within 1 hour

Not for patients with new neurological deficets, previous anerysms, SAH, brain tumours, or history of similar headaches (≥3 episodes over ≥6 months)

Patients require investigation if one or more findings present:

Symptoms of neck pain or stiffness

2

Age ≥ 40 years old

3

Witnessed loss of consciousness

4

Onset during exertion

5

Thunderclap headache (peak intensity immediately)

6

Limited neck flexion on exam

- Simple
- Clinical question
- Derivation Validation Implementation
- Health care system
- Cost effective

"HIGH QUALITY CLINICAL DECISION RULES MAKE GOOD EMERGENCY PHYSICIANS BETTER BUT CAN MAKE BAD DOCS EVEN WORSE"

- Clinical impression
- Integration into clinical reasoning
- Behaviour Change

Canadian CT Head Rule

CT head is only required for minor head injury patients with any one of these findings:

High Risk (for Neurological Intervention)

- 1. GCS score < 15 at 2 hrs after injury
- Suspected open or depressed skull fracture 2.
- 3. Any sign of basal skull fracture*
- 4. Vomiting ≥ 2 episodes
- 5. Age \geq 65 years

Medium Risk (for Brain Injury on CT)

- 6. Amnesia before impact ≥ 30 min
- Dangerous mechanism ** (pedestrian, occupant ejected, fall from elevation)

*Signs of Basal Skull Fracture


 hemotympanum, 'racoon' eyes, CSF otorrhea/ rhinorrhea, Battle's sign

** Dangerous Mechanism

- pedestrian struck by vehicle
- occupant ejected from motor vehicle
- fall from elevation ≥ 3 feet or 5 stairs

Rule Not Applicable II:

- Non-trauma cases
- GCS < 13
- Age < 16 years
- Coumadin or bleeding disorder
- Obvious open skull fracture



- hit by high speed vehicle
- *** Delayed:
- i.e. not immediate onset of neck pain
